The Member at Member's sole risk shall undertake all exercises and use of all tennis and pickleball facilities. The Ritz-Carlton, Half Moon Bay, and The Half Moon Bay Tennis Academy shall not be liable for any Members or their guests for injuries, damages, actions, or causes of action whatsoever, to person or property arising out of or connected with the use of any of the tennis or pickleball facilities of The Ritz-Carlton, Half Moon Bay or premises where the same are located or arising out of acts of active or possible negligence on the part of The Ritz-Carlton, Half Moon Bay, its officers, employees or agents or The Half Moon Bay Tennis Academy, its officers, employees or agents.

**No Assumptions of Liability or Ownership:** Charter shall charge no special assessments charged to members. Only regular dues and accrued charges will be billed. Racket Membership at The Ritz-Carlton, Half Moon Bay implies no liability whatsoever other than the agreement to pay dues, any

charges made by the member, family or member's guests, designated corporate member and the initiation fee. Racket Membership constitutes a conditional right of use and conveys no ownership or proprietary interest in The Ritz-Carlton, Half Moon Bay, its property or assets. The Ritz-Carlton, Half Moon Bay, and The Half Moon Bay Tennis Academy also assume no liability for items left on the premises.

**Rules:** It is agreed that the Racket Membership and all persons using the tennis and pickleball courts hereunder are bound and shall comply with all rules and regulations of the tennis and pickleball courts as they may be amended from time to time. Failure to do so may result in termination of the membership. A copy of the Racket Rules & Regulations will be provided to each member.

**Racket Membership Privileges:** The Racket Membership provides access to the tennis courts, pickleball courts and tennis pro shop only. Racket members may reserve courts for day or evening play up to 7 days in advance, reserve the ball machine, rent equipment, play on USTA or other league teams and take private or group instruction from the tennis and pickleball professionals at the membership rate. Access to the swimming pool, fitness center and locker room is not included in the Racket Membership.

**Suspensions of Membership:** I understand that I may suspend my membership in the event of injury once per calendar year for 30 days, with the option to extend to 60 days, without being subject to the Initiation Fee again. All other suspensions of membership will result in payment of the Initiation Fee when the member rejoins.

**Resignation:** Should I decide to terminate my membership, I understand that I must notify The Colony Club in writing 30 days in advance and pay my account balance in full.
